PRODUCT DESCRIPTION

Polyglaze PZ Stone Sealer is an eco-friendly formulation that protects stones from moisture and general natural stains such as mud, mildew and environmental changes. The anti-stain action is due to its technologically advanced formulation, which provides protection deep inside the stone pores for a long period of time. It does not change the natural aspect of the stone surface and does not create any type of film or plastic effect, while allowing vapour to escape.


STORAGE & SHELF LIFE

- ◆ Store in a dry place away from moisture and sunlight
- ◆ 24 months from the date of manufacture in unopened sealed condition

PRECAUTIONS & LIMITATIONS

- ◆ Always perform a patch test on a small area before full application to check for surface compatibility and desired results
- ◆ Clean all tools with water immediately after use
- ◆ Mix well before use

APPLICATION METHODOLOGY



Clean the surface with water. Ensure it is dry and dust free



Apply Polyglaze PZ Stone Sealer on the surface using a brush, cotton cloth or sponge.



Apply the second coat after 60 minutes of the first coat drying.



Wipe off excess residue with a cotton cloth or buffing pad after 2 hours. Allow it to cure for 24 hours.

COVERAGE

- ◆ Approx. 10 - 30 sq.m / litre per coat, depending on the porosity of the surface.
- ◆ Coverage will vary depending on the weather conditions, porosity, smoothness of the surface and application thickness

HEALTH & SAFETY

- ◆ Use a respiratory mask and protective gloves during application.
- ◆ Clean hands with soap and water after application.
- ◆ Avoid contact with skin / eyes. In case of unlikely contact, rinse eyes immediately with plenty of clean water and cleanse skin with soap and lukewarm water. Seek medical advice if irritation occurs / persists.
